Rules & Regulations for Vendor Participation

(please initial to acknowledge)

- _____ Vendors cannot sublease or assign any part of the assigned vendor booth to other parties.
- _____ Vendors are allowed only to promote their product from their assigned booth.
- _____ The City of Belton reserves the right to relocate a vendor for any reason. Spot requests cannot be guaranteed.
- _____ The sale of animals, firearms, and objectionable material is prohibited.
- _____ Vendors are limited to selling the items listed on their application and are responsible for obtaining all appropriate certificates.
- _____ **Vendor check-in is Friday, September 26th, starting at 2:00 PM and ending at 4:00 PM. Vehicles will not be permitted in loading/unloading areas after 4:00 PM. No exceptions. Anyone not in place by 4:00 PM will be considered a "no show" vendor, will be removed from our mailing list, and deemed ineligible to participate in the future.**
- _____ **Tear down is Saturday, September 27th at 10:00 PM. Any vendor failing to comply will be removed from our mailing list and deemed ineligible to participate in the future. Early tear down is unsafe and unfair.**
- _____ Vendors are responsible for all applicable City and State taxes for merchandise sold at event.
- _____ All attempts will be made to hold the event; however, in the event of cancellation you may receive a refund of vendor fees paid.
- _____ If vendor needs to cancel, cancelations must be made by Sept. 17th to receive a full refund.
- _____ All vendors must be 18 years or older.
- _____ All vendors will be responsible for their own trash in and around their booth area, as well as the disposal throughout the event. All items must be taken at the end of the event. Any items left will be considered trash and disposed of immediately following the event.
- _____ Displays, tables, chairs, awnings, and props are the vendor's responsibility. No such materials may obstruct other vendor's booths or sidewalks.
- _____ The City of Belton reserves the right to settle any disputes that may arise from said issue.
- _____ Vendors must have a Special Events Permit from TABC
